## Sweepstakes Official Rules

Employees of Puslinch Today, its affiliates, subsidiaries, advertising and Sweepstakes agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, provincial/territorial, and local laws and regulations. Void where prohibited.

**3. Sweepstakes Period:** Entries will be accepted starting on January 7, 2020 at 11:00:00 AM EST and ending January 13, 2020 at 5:00:00 PM EST (“Sweepstakes Period”). All other entries are void as ineligible.

**4. Multiple entries by You using multiple email addresses, identities, or devices, or other attempts to circumvent the Rules will disqualify You. If You use fraudulent methods or otherwise attempt to circumvent the Rules, Your submission may be removed from eligibility at the sole discretion of Puslinch Today. Incomplete or illegible entries will not be acknowledged and will not be included in the Sweepstakes drawing. All entries become the exclusive property of Puslinch Today and will not be returned or acknowledged except as provided herein. No other attempted form of entry, including via email or fax, will be accepted. Entrants agree to be contacted by Puslinch Today with notices and reminders pertaining to the Sweepstakes.

**5. Winner Selection and Notification: Five (5)** winners will be selected at random by drawing under the supervision of Puslinch Today on or about January 13, 2020. Winner will be notified by a direct message on Facebook Messenger within fifteen (1) day following the selection of Winner. If Winner is a resident of Canada, arrangements will be made to administer a mathematical skill-testing question, which will be administered by phone or email (at Puslinch Today’s discretion), and potential winner will be required to correctly answer the question without mechanical or other assistance to receive the prize. Puslinch Today shall have no liability for Winner’s failure to receive notices for any reason. If Winner cannot be contacted, is found to be ineligible, fails to claim the prize within thirty (1) day from the time award notification was sent, fails to answer the skill-testing question correctly (as applicable) or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited, and an alternate Winner may be selected.
